On behalf of **GLOBE**, the **Ontario Power Authority** and the **City of Toronto's Better Buildings Partnership (BBP)**, I am inviting you and/or your staff to attend an information session on how you can take advantage of the **Multifamily Energy Efficiency Rebate (MEER) Program**.

There is no cost for you to attend.

MEER is an excellent opportunity to recoup funds for energy savings projects **between January 1, 2008 and December 31, 2010**. If your multi-family residential building(s) are greater than 6 dwelling units, situated within the boundaries of Toronto you may be eligible for MEER.

Retrofit projects that are eligible for MEER include energy audits, heating and ventilation upgrades, plumbing system upgrades, lighting upgrades, building envelope upgrades (windows, insulation) as well as installation of select Energy Star products, ground source heat pumps and solar hot water collectors.

In this session, you will learn:

- MEER eligibility criteria
- Eligible prescriptive and calculated measures and incentive levels
- How to apply for MEER on eligible work already done and yet to be done
- Demonstration on "How to complete the application"
- How MEER works with SHRRP and other available incentive programs
- How to qualify for resident educational information sessions
- Available supports
